### DETAILED SUMMARY

A monthly report will be provided that compares the Railroad's actual financial performance against its budget and/or forecast.

### **Procurements**

List of procurement action items requiring Board approval. The Non-Competitive items will be first, followed by the Competitive items and then the Ratifications. The list will include items that need a 2/3 vote of the Board for approval.
