# JOB DESCRIPTION

**Bus Maintainers - Group B**, under supervision, maintain, inspect, test, diagnose, alter, rebuild and repair electrical, electronic, mechanical, hydraulic, pneumatic and air conditioning equipment of MTA New York City Transit's buses, trucks and other motor vehicles. They inspect, test, alter and repair diesel and gasoline engines, hybrid natural gas/electric engines/motors, inverters, high pressure fuel systems, clutches, transmissions, axles, generators, compressors, air conditioning systems, brake assemblies, door wheelchair lifts, and electrical and mechanical accessories, align, adjust and/or repair wheels, steering equipment and suspension systems; reline and adjust brakes and clutches; diagnose and repair modular automotive multiplex systems; operate power machine tools and portable power tools; use electronic diagnostic tools; use hand tools; record data and keep records; use computerized equipment; drive motor vehicles; may travel for training and vehicle inspection functions; and perform related work.

Some of the physical activities performed by Bus Maintainers – Group B and environmental conditions experienced are: crawling under buses and working in confined areas; lifting and carrying heavy equipment; moving out of the way of moving buses and overhead cranes; manually removing and installing parts and bolts in confined areas; making visual inspections of equipment; distinguishing colors; reading gauges and prints; responding to sounds from warning bells, horns and vehicle movement; and working outdoors in all weather conditions.

**Special Working Conditions**: Bus Maintainers - Group B may be required to work various shifts, including nights, Saturdays, Sundays and holidays.

(This brief description does not include all of the duties of this position.)

## **SALARY**

The current minimum salary for Bus Maintainer - Group B is \$33.84 per hour for a 40-hour work week increasing to \$39.81 in the sixth year of service. These rates are subject to change.

# **ELIGIBILITY TO TAKE EXAMINATION**

This examination is open to each employee of MTA New York City Transit who **on the first date of the multiple-choice test**:

- 1. Is or has been employed in the non-competitive title of Transit Mechanical Apprentice and has satisfactorily completed the 2-year Transit Mechanical Apprentice program in bus maintenance and is employed in the Department of Buses; or
- 2. Is permanently (not provisionally) employed in or appears on a Preferred List (see Note, below) for the eligible title of Maintainer's Helper Group B and has been permanently employed in such title in the Department of Buses; and
- 3. Is not otherwise ineligible.

(Note: A "Preferred List" is a civil service list which is only for certain former permanent incumbents of the eligible title who have rehiring rights.)

This examination is also open to employees who were appointed to an eligible title pursuant to New York State Civil Service Law, section 55-a, and who meet all other eligibility requirements.

The admission of employees who completed the Transit Electrical Apprentice program as a non-competitive Transit Electrical Apprentice is on a collateral basis pursuant to Section 52(12) of the New York Civil Service Law.

You are responsible for determining whether you meet the eligibility requirements for this examination prior to applying. If you do not know if you are eligible, check with **your department's Human Resources representative.** You may be given the multiple-choice test before we verify your eligibility. However, only candidates who meet the eligibility requirements in this section will be scheduled for the multiple-choice test. If you are marked "Not Eligible," you will not be given the multiple-choice test, your application fee will **not** be refunded, and you will **not** receive a score.

This examination is <u>not</u> open to employees of MaBSTOA or MTA Bus Company, or to employees of MTA agencies other than MTA New York City Transit.

## THE TEST

You will be given a <u>competitive</u> multiple-choice test and a <u>qualifying</u> structured interview. A score of at least 70% is required to pass the <u>competitive</u> multiple-choice test and the <u>qualifying</u> structured interview. Only those who meet the <u>qualifying</u> education and experience requirements and pass the competitive multiple-choice test will be scheduled to take the qualifying structured interview.

You will be scheduled to take the multiple-choice test on one of the dates listed in the above "Test Date" box. You will be assigned to a test date and location, and you cannot request that your scheduled test date or location be changed, unless you meet the conditions in the "Special Test Accommodations" subsection below.

Your score on the <u>competitive</u> multiple-choice test will determine 85% of your final score. Your seniority will determine the remaining 15%. You must pass the <u>competitive</u> multiple-choice test and the <u>qualifying</u> structured interview to have your seniority credited. Your seniority score will be 70 plus ½ point for each three months of completed, permanent, continuous service with an agency under the jurisdiction of the Commissioner, Department of Citywide Administrative Services, in competitive class titles. Your service will be credited through the first date of the <u>competitive</u> multiple-choice test, up to a maximum of 15 years. Time served prior to a break in service of more than one year will not be credited.

Veterans' or Disabled Veterans' Credit will be granted only to eligible passing candidates who request that they be applied. Veterans' or Disabled Veterans' Credit should be requested at the time of application but **must** be requested before the date the eligible list is established. Claims for Veterans' or Disabled Veterans' Credit cannot be made once the eligible list is established.

The <u>competitive</u> multiple-choice test and <u>qualifying</u> structured interview may measure your knowledge, skills and abilities in the following and other related areas:

- **Automotive Theory**: Knowledge of maintenance, troubleshooting and repair of buses, automobiles and trucks, including their engines, transmissions, running gears, air-conditioning, and electrical and mechanical accessories, utilizing safe work practices
  - o Example: Using proper automotive maintenance techniques to maintain a bus
- Tool Usage: Ability to properly select and safely use materials, machinery and tools of the trade
  - Example: Using a screwdriver to remove a screw
- Schematics: Ability to read and interpret specifications and drawings
  - o Example: Using a circuit schematic to trace the circuit you are working on
- Mathematic Calculations: Ability to perform mathematical calculations
  - Example: Performing a calculation to determine the length of wire needed for a task
- **Vehicle Component Maintenance:** Ability to install, repair, and adjust vehicle components utilizing safe work practices
  - o Example: Performing a wheel alignment
- **Testing Devices**: Ability to properly and safely troubleshoot and repair electrical components using meters and other equipment
  - o Example: Using a multimeter to determine if a fuse is blown

# **HOW TO SUBMIT AN APPLICATION**

If you believe you meet the requirements in the "Eligibility to Take Examination" section, you may submit an application during the application period. The MTA Exam Information Center, located in the lobby of 180 Livingston Street, Brooklyn, NY 11201, is <u>currently closed</u>. If you believe you have a special circumstance (e.g., a disability, military duty) that prevents you from applying as instructed below, please refer to the Special Circumstances Guide referenced in the "Special Arrangements" section below. Applications will **not** be accepted in person.

# Online Applications:

1. If you are an active MTA employee, apply using the "BSC" employee portal at <a href="www.mymta.info">www.mymta.info</a>
by the last day of the application period (non-active MTA employees and applicants requesting a fee waiver must email us by the last day of the application period at <a href="mailto:examsunit@nyct.com">examsunit@nyct.com</a> for application instructions).

<u>Note</u>: The application system may not function properly with mobile devices or tablets. For best results when applying, please use the latest version of Microsoft Edge, open a new window, and avoid having multiple tabs open in the same window.

- 2. Once you have logged in, click on the My Job Search ribbon and then click on Exams (non-Railroad).
- 3. Follow the steps to submit an application.
- 4. Active MTA employees must pay the application fee via payroll deduction.
- 5. A confirmation number will appear on the same page after submitting your application and authorizing a payroll deduction (Save this number for future reference).

<u>IMPORTANT</u>: Your application submission confirms that you have read this Notice of Examination, including any dates and the requirements.

**Application Fee**: This fee is generally not refundable. Under special circumstances, you may be entitled to a refund. Please refer to the Department of Citywide Administrative Services ("DCAS") General Exam Regulation E.3.4 to determine if you are entitled to a refund. **Late Applications**: Refer to the "Correspondence" section below to contact the Examinations Unit to determine the procedure for submitting a late application if you meet one of the following conditions:

- 1. You are absent from work for at least one-half of the application period and are unable to apply for reasons such as vacation, sick leave or military duty; or
- 2. You become eligible after the above application period, but before the first test date.

**Special Test Accommodations:** If you plan to request an alternate test date due to your religious observance or special testing accommodations due to disability, please follow the instructions included in the Special Circumstances Guide, which is accessible online at <a href="http://web.mta.info/nyct/hr/forms\_instructions.htm">http://web.mta.info/nyct/hr/forms\_instructions.htm</a> and will be attached to this Notice of Examination during the application period. An alternate test date due to religious observance must be requested no later than 15 days prior to the date on which the structured interview is expected to begin. Special testing accommodations due to disability must be requested no later than 30 days prior to the date on which structured interview is expected to begin.

**Make-Up Tests:** You may apply for a make-up test if you cannot take the multiple-choice test and/or structured interview as scheduled for any of the following reasons:

- 1. Compulsory attendance before a public body; or
- 2. On-the-job injury or illness caused by municipal employment where you are an officer or employee of the City; or
- Absence from the test within one week after the death of a spouse, domestic partner, parent, sibling, child, or child of a domestic partner where you are an officer or employee of the City; or
- 4. Absence due to ordered military duty; or
- 5. A clear error for which MTA New York City Transit is responsible; or
- 6. A temporary disability, pregnancy-related, or child-birth related condition preventing you from taking the test.

## **CORRESPONDENCE**

**Change of Contact Information:** It is critical that you keep your contact information (i.e., telephone number, mailing address and/or email address) current with MTA New York City Transit.

You may miss important information about your exam(s) or consideration for appointment or promotion, including important information that may require a response from you by a specified deadline, if we do not have your correct contact information. To update your contact information, you may:

Your request must include your full name, exam title(s), exam number(s) and your old and new telephone numbers, mailing and/or email address. ## **TEST SITE REQUIREMENTS**

An Admission Letter will be mailed to you about 10 days before the first date of the multiple-choice test. If you do not receive an Admission Letter at least 4 days before this date, you must email a request for a duplicate Admission Letter to <a href="mailto:examsunit@nyct.com">examsunit@nyct.com</a>. A paper copy of the Admission Letter is your ticket for admission to the test.

Applicants **must** keep their mailing address **up to date**. Please refer to the "Correspondence" section above for instructions on how to update your address and other contact information.

**Warning:** You are not permitted to enter the test site with cellular phones, smart watches, beepers, pagers, cameras, portable media players, or other electronic devices. Calculators are permitted; however, they must be hand-held, battery or solar powered, numeric only. Calculators with functions **other than** addition, subtraction, multiplication and division **are prohibited**. Electronic devices with an alphabetic keyboard or with word processing or data recording capabilities such as planners, organizers, etc. are prohibited. If you use any of these devices in the building at any time before, during or after the test, you may **not** receive your test results, your test score may be nullified, and your application fee will **not** be refunded.

**Social Distancing** and other safety protocols, **including the wearing of masks**, may be required during the administration of the test. Further details will be provided on your admission letter.

You may not have any other person, including children, present with you while you are being processed for or taking the test and no one may wait for you inside of the test site while you are taking the test.

**Leaving:** You must leave the test site once you finish the test. If you leave the test site after being fingerprinted but before finishing the test, you will not be permitted to re-enter. If you disregard this instruction and re-enter the test site, you may not receive your test results, your test score may be nullified, and your application fee will not be refunded.

**Proof of Identity:** You must present your MTA New York City Transit employee ID when you arrive to take the test

#### THE TEST RESULTS

If you pass the <u>competitive</u> multiple-choice test and the <u>qualifying</u> structured interview and are marked eligible, your name will be placed in final score order on an eligible list and you will be given a list number. You will be notified by mail of your test results. You will be considered for promotion when your name is reached on the eligible list.

## REQUIREMENTS TO BE PROMOTED

**From the non-competitive title of Transit Mechanical Apprentice**: At the time of promotion, you must be employed or have been employed in the title of Transit Mechanical Apprentice.

From the competitive title of Maintainer's Helper – Group B: At the time of promotion, you must have completed your probationary period in the eligible title of Maintainer's Helper- Group B and you must be permanently employed in that eligible title or your name must appear on a Preferred List for that eligible title. Additionally, you must have served permanently in the eligible title of Maintainer's Helper – Group B for at least one year.

**Driver License Requirement:** At the time of appointment, you must possess a Motor Vehicle Driver License valid in the State of New York.

Within 14 days of appointment, you must obtain a Learner Permit for a Class B CDL valid in the State of New York with a passenger endorsement and no airbrake restrictions, or any other disqualifying. Additionally, a Class B CDL valid in the State of New York with a passenger endorsement, no airbrake restrictions, and no other disqualifying restrictions must be obtained within 120 days of appointment, or your employment will be terminated. If you have serious moving violations, a license suspension, or an accident record, you may be disqualified.

The Class A or Class B Commercial Driver License (CDL) with a passenger endorsement, no airbrake restrictions and no other disqualifying restrictions must be maintained for the duration of your employment in the title. Such license must not include any restrictions which would preclude the performance of Bus Maintainer (Chassis) work.

Commercial Motor Vehicle Driving Experience in the Military or New York National Guard: If you are an active member or former member (discharged in the past year) of the military or New York National Guard and have experience driving a Commercial Motor Vehicle in the military or New York National Guard, you may be eligible for a waiver of the New York State commercial driving skills test through the New York State Department of Motor Vehicles. If you believe that you may be eligible for this waiver, you must apply for the waiver through the New York State Department of Motor Vehicles.

**Medical Requirement:** Medical guidelines have been established for the position of Bus Maintainer – Group B. Candidates will be examined to determine whether they can perform the essential functions of the position of . Where appropriate, a reasonable accommodation will be provided for a person with a disability to enable such person to perform the essential functions of the job.

**Drug Screening Requirement:** You must pass a drug screening in order to be promoted, and if promoted, you will be subject to random drug and alcohol tests for the duration of your employment. Additionally, if you have tested positive on a drug or alcohol test or had a refusal to test during preemployment or while employed by a Federal DOT-regulated employer during the applicable period, you must have completed the Substance Abuse Professional (SAP) evaluation, referral and education/treatment process required by federal law in order to be promoted to this safety-sensitive position.

# ADDITIONAL INFORMATION

**Training:** You may be required to undergo a formalized training course during your probationary period. Failure to successfully complete the training course may result in termination or being returned to your previously held permanent title.

**Probationary Period:** You will be required to complete a probationary period. If you do not successfully complete the probationary period, you may be terminated or returned to your previously held permanent title.

# PENALTY FOR MISREPRESENTATION

Any intentional misrepresentation on the application or examination may result in disqualification, even after promotion, and may result in criminal prosecution.
