Retain Passes Notes

If the cash fare is eliminated, the 30 Day Pass price could increase by up to an additional \$0.50.

If the SRT fare is increased to \$4.00 and the cash fare is eliminated, the 30 Day Pass price increase could be reduced by up to \$0.25.

If the SRT is eliminated, there would be no impact on other fares.

Retain Passes Notes

If the cash fare is eliminated, the 30 Day Pass price could increase by up to an additional \$0.25.

If the SRT fare is increased to \$4.00, the 7 Day Pass price increase could be reduced by up to \$0.25, and the 30 Day Pass price increase could be reduced by up to \$0.75.

If the SRT is eliminated, there would be no impact on other fares.
