Central Business District Tolling Program Public Information Outreach Meetings for Environmental Justice Communities

The April 2019 Traffic Mobility Act authorized the Triborough Bridge and Tunnel Authority (TBTA) to design, develop, build, and implement a Central Business District (CBD) Tolling Program. The program is being designed to reduce congestion in the CBD and provide a reliable revenue source for investment in the region's mass transit network. The CBD would include the geographic area in Manhattan south and inclusive of 60th Street, except for the FDR Drive, the West Side Highway, Battery Park Underpass and any surface roadway portions of the Hugh L. Carey Tunnel connecting to West Street. Vehicles entering, or remaining in, the Manhattan CBD would pay a toll, which would be collected via a cashless tolling system.

As part of the federal approval process TBTA, together with New York City Department of Transportation (NYCDOT) and New York State Department of Transportation (NYSDOT), and in close coordination with the Federal Highway Administration (FHWA), the federal lead agency, is required to ensure that Environmental Justice Communities in the relevant counties in New York, New Jersey and Connecticut have a chance to learn about and weigh in on the project.
