Figure D-1. 2010 Census Tracts: Segment 1 (Corridor)



Figure D-2. 2010 Census Tracts: Segment 2 (Corridor and Hunts Point Station Area)





Figure D-4. 2010 Census Tracts: Segment 4 (Corridor)


